<p>A description of the steps the program has taken to decrease the use of restraint and involuntary seclusion.</p>	<p>On a weekly basis, children in the program with multiple holds are discussed with the treatment team members and therapists. Specific reasons as to why holds are happening, such as medication changes, topics being discussed in therapy, or visits and contact with families are examined. Once a month, all of the restraint and seclusion data is discussed by the Quality Assurance Committee and factors such as length of placement, medications, and specific staff/child interactions are discussed by the committee.</p>
